Therefore, as per the University Notification No. COE/MAKAUT, WB/24/2026 dated 02.07.2026, all concerned students are hereby informed that:

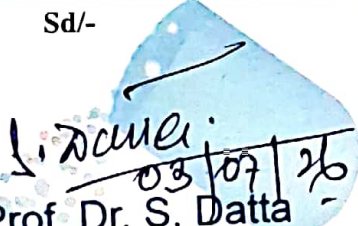
