Subject: Enrolment Fee & Examination Fee Structure for Odd Semester 2025-2026 – Notification from MAKAUT, WB.

This is to bring to your notice the official notification issued by **Maulana Abul Kalam Azad University of Technology, West Bengal (MAKAUT, WB)**, regarding the revised fee structure and late fee/penalty provisions for the upcoming academic session, **Odd Semester 2026-2027**. The same has been approved by the Competent Authority and is effective from the ensuing **Odd Semester 2026-2027 onwards.**

Important Schedule for 3rd, 5th, and 7th Semester Students:

1. **Enrolment Period (for students of 3rd, 5th, and 7th Semesters):** All concerned students are required to complete their enrolment formalities between **05.08.2026 and 14.08.2026**.
2. **Fee Submission for Enrolment:** The fee payment window for enrolment will be open on and from **17.08.2026 to 18.08.2026**. Students are advised to clear their dues within this stipulated window to avoid any late fee.

For your convenience, the salient points are summarised below:

Examination Fee	₹ 1,200/-	₹ 1,000/-	No change; backlog fee to be paid at enrolment.
Enrolment Fee	₹ 100/-	Not applicable	Newly introduced, to be collected at semester start.
Late Fee for Enrolment (second window)	₹ 500/-	₹ 500/-	Applicable if enrolment is not completed by the original due date.
Late Fee for Exam Form Submission (additional date)	₹ 2,000/- (lump sum)	₹ 2,000/- (lump sum)	For all candidates who miss the original form-submission deadline.

Other Key Points to Note:

1. Examination Fee for Regular candidates remain unchanged at ₹ 1,200/-; for Backlog candidates it is ₹ 1,000/- (collected at enrolment).
2. Enrolment Fee of ₹ 100/- is now applicable to all Regular students. It will be charged once per semester at the time of enrolment.
3. Late fee options have been introduced to provide an additional opportunity for students who, due to genuine reasons, are unable to complete formalities on time. However, we strongly advise all students to strictly adhere to the dates mentioned above (05.08.2026 – 14.08.2026 for enrolment, and 17.08.2026 – 18.08.2026 for fee submission) to avoid extra charges.
4. The exact dates for the second enrolment window and the extended date for examination form submission will be notified separately by the



Controller of Examinations. We will share these updates as soon as they are announced.

All students are requested to read the full university notification (attached) and plan their fee payments accordingly.

Kindly check the college notice board and your registered email regularly for further updates.

NOTIFICATION

Subject: Enrolment Fee and other fees for examination

It is notified for the information of all students and the Principals/Directors of all affiliated Colleges of MAKAUT, WB that, on the recommendations of the Committee constituted vide Notification No. MAKAUT/Regis/Committee/088/2026-27 dated 16.01.2026, and upon consideration of the matter by the University's Finance Committee, the Competent Authority has approved the fee structure and late fee/penalty provisions set out below, with effect from the ensuing academic session/semester.

The University wishes to place on record that these measures have been introduced keeping in view the interest and convenience of the students. It has been observed that certain students, owing to genuine difficulties beyond their control, are occasionally unable to complete the enrolment formalities or submit examination forms within the originally notified schedule. Rather than close the process at the due date and thereby risk a student losing an academic semester, the University has decided to extend a further opportunity to such students, on payment of a modest late fee, so that they are not deprived of the chance to enrol or to appear in the examinations. The introduction of the Enrolment Fee has similarly been undertaken to institutionalise and strengthen the enrolment process and the student services associated with it. The relevant provisions are summarised below.

(A) Examination Fee — No Change

The Examination Fee shall remain unchanged, viz. Rs. 1,200/- (Rupees One Thousand Two Hundred only) per student for Regular candidates, and Rs. 1,000/- (Rupees One Thousand only) per student for Backlog candidates. In respect of Backlog students, this Examination Fee shall continue to be collected at the time of enrolment itself, since such students are already eligible to appear in the examinations; accordingly, no separate Enrolment Fee shall be charged from Backlog students.

(B) Enrolment Fee — Newly Introduced

An Enrolment Fee of Rs. 100/- (Rupees One Hundred only) per student shall be introduced for all Regular students, to be collected at the time of enrolment at the commencement of each semester.

(C) Late Fee for Enrolment After Due Date

Where a student is unable to complete enrolment within the last date originally notified, a second enrolment window shall be opened, on payment of a late fee of Rs. 500/- (Rupees Five Hundred only) per student, applicable to both Regular and Backlog students, so as to afford them an additional opportunity to enrol.

(D) Late Fee for Submission of Examination Forms After Due Date

Where a Regular or Back Paper candidate is unable to submit the examination form within the last date originally notified, an additional date shall be provided for submission, on payment of a late fee/penalty of Rs. 2,000/- (Rupees Two Thousand only), lump sum, so as to give such candidates a further opportunity to appear in the examinations.
